REQUIREMENT: Must be willing to be publicly identified as a Democrat

WHEN TO APPLY: January 28 - March 31, 2024 at 5:00 PM

WHEN SELECTED: Elected at LD Caucus April 6, 2024 by the LD membership **Virtual Ballot**

District-Level Pledged Delegates (National Delegates)

ABOUT: Allocated to Presidential Candidates based on results of the presidential primary by performance in each Congressional District (CD)

REQUIREMENT: Must be registered to vote in CD they are running in and willing to be publicly identified as a Democrat

WHEN TO APPLY: April 12 - May 12, 2024 at 5:00 PM

WHEN SELECTED: Elected by May 18, 2024 by LD Elected Delegates **Virtual Ballot**

PLEO (Pledged Party Leaders and Elected Officials)

ABOUT: Allocated to Presidential Candidates based on results of the presidential primary

REQUIREMENT: Consideration will be given in Priority Order as follows: big city mayors and state-wide elected officials, state legislative leaders, state legislators, and other state, county and local elected officials and party leaders

WHEN TO APPLY: May 23 - June 2, 2024, at 5:00 pm

WHEN SELECTED: Chosen by members of the Washington State Democratic Central Committee (WSDCC) Elected by their LD June 9, 2024 **Virtual Ballot**

WHEN SELECTED: Chosen by members of (WSDCC) June 9, 2024 **Virtual Ballot**

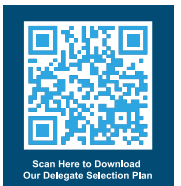

March 12 - Presidential Preference Primary

March 31 - Deadline to declare for State Level Delegate

April 6 - State Level Delegates elected

May 12 - Deadline to declare for National Delegate

May 18 - National Delegates Elected by Congressional District

June 2 - Deadline to apply for PLEO/At-Large National Delegate

June 9 - Remainder of Delegation Chosen via virtual ballot

June 21-23 - Washington State Convention

Aug 19-22 - Democratic National Convention in Chicago
